1. Welcome, attendance, apologies

The Chair opened the meeting at 11.03am.

The Chair noted those who were apologies for the meeting and confirmed a quorum present.

The Chair reprioritized the agenda, which the Committee **supported** and welcomed Dr Kelly Stephens from the University of Technology Sydney, to the meeting.

6. Presentation: Towards High Quality in Australian Education Technology

The Committee noted a presentation on research ([OPUS at UTS: Towards high quality in Australian educational technology - Open Publications of UTS Scholars](#)) co-authored with Dr Leslie Loble, AM Industry Professor at the University of Technology Sydney, which was taken as read.

The Chair invited Dr Kelly Stephens to present on the research funded by Paul Ramsay, noting that improving educational outcomes, especially for students experiencing disadvantage, should be our highest priority across the education sector and a key focus for government.

The Committee noted the research findings report that:

- Strengthening evidence that AI-enabled learning tools can lift student outcomes & support teachers, but only if high quality, effectively used & closely governed
- The capacity to use these learning tools risks becoming the next frontier of the digital divide, especially as they increasingly form a mediating layer between curriculum & classroom
- Australia needs a national mechanism to independently assure the quality of digitally enabled teaching and learning resources with clear criteria and robust and transparent assessment process; and
- Existing international quality assurance mechanisms offer a guide: outlining the core quality dimensions and the typical assessment process

The Committee noted the research argues for a national quality assurance process for Edtech, with clear criteria and robust and transparent assessment process.

It was further noted that Edtech has the potential to help close the learning and digital divide to support all learners by:

- Identifying learning difficulties
- Assisting student with lower prior knowledge; and
- Scaling effective tuition.

The Committee noted co-design is crucial, with teachers being central to the development of criteria, the QA process and assessment of resources with wider stakeholder expertise.

The Committee asked questions and commended Dr Stephens on the research presented.

Dr Stephens left the meeting and the Chair reverted to the agenda, as tabled.

The Chair congratulated Dr Bruce Tonkin as auDA's new CEO, commencing 1 January 2025 and provided thanks to incumbent CEO, Rosemary Sinclair AM for her contribution to the Committee, wishing her well for the future.

The Committee noted the standing Declarations of Interests Register and confirmed there were no updated interests to declare and no conflicts of interest.

7. Identity Digital Wholesale Price Increase

The Chair invited auDA's COO to update the Committee on the wholesale price increase of the .au domain name licence, which was published on 22 July 2024 (<https://www.auda.org.au/statement/statement-au-domain-name-licence-wholesale-price>).

The Committee queried whether the increase was sufficient with consideration of inflation and rising costs, which was discussed.

No other comments or questions were noted.

8. ESA Quarterly Report Update for FY24 Quarter 1

The edu.au Domain Registrar Progress Report for the April - June 2024 (FY24 Q4) reporting period was tabled as read, as also distributed

The Chair invited Amanda Shay from ESA to provide the Committee a summary of from the July - September (FY25 Q1) period which included key activities, issues, operational outcomes and trends for the reported quarter.

The Committee noted that ESA is considering what the retail impact will be to different sectors, following the wholesale price increase noted and discussed (agenda 7 above).

The Committee noted an update on .au direct applications which have been contested, which auDA COO responded to noting the .au licensing rules were released in 2021 with public consultation undertaken and are scheduled for another review in 2025.

No further comments were noted.
