In regards to the **.au Licensing Rules – Open Consultation**, we would like submit that domains that are part of the same company group and are directly related to a licensed entity should still be allowed to register. For example in our situation, we have operating companies, Voxark Pty Ltd, Loxiva Pty Ltd and Roxela Pty Ltd, which hold service approvals from the Department of Education but are supported by Oxanda Education Pty Ltd. It should be allowable for us to continue to use oxanda.edu.au because we refer to ourselves as the 'Oxanda Childcare Group' and Oxanda is the first word in Oxanda Education Pty Ltd.
