1. Declares Highland Group Pty Ltd to be the registrant of each of the Disputed Domain Names other than <rainbow.org.au> and therefore the proper applicant for the purposes of this Application;
2. Directs that the domain names listed above other than <blonk.com.au>, <siji.com.au> and <rainbow.org.au> be re-instated as active domain names under their current registrants and that all server locks be removed;
3. Declares *Web Rainbow* to be the proper registrant of <rainbow.org.au>;
4. Directs that <rainbow.org.au> be re-instated as an active domain name with *Web Rainbow* recorded as registrant and that all server locks be removed provided that if Synergy Wholesale Pty Ltd is not satisfied within 14 days of receiving a copy of this order that the *Web Rainbow* club actually exists, the domain name is to be placed in Policy Delete;
5. Directs that <blonk.com.au> and <siji.com.au> be placed in Policy Delete and that all server locks other than the Delete Prohibited lock remain in place until deletion has been effected;
6. Directs auDA forthwith to provide to Synergy Wholesale Pty Ltd a copy of the Panel's Reasons for Decision in RRP20195251, together with a copy of these orders.
