

### auDA PUBLISHED POLICY

Policy Title: DOMAIN RENEWAL, EXPIRY AND DELETION POLICY

### 1. BACKGROUND

1.1 This document sets out auDA's policy on the renewal, expiry and deletion of domain names in the open .au second level domains (2LDs). At the time of publication, the open 2LDs are asn.au, com.au, id.au, net.au and org.au.

1.2 This document does not detail the technical steps required to renew or delete a domain name. This information is contained in the registry's technical procedures manual, which is made available to all auDA accredited registrars.

### 2. DOMAIN NAME RENEWAL

- 2.1 The domain name licence period is fixed at 2 years. This means that when a domain name is registered or renewed, it has a fixed expiry date 2 years from the date of registration of renewal. For example, if a domain name is registered or renewed on 1 January 2006, the expiry date is 1 January 2008.
- 2.2 Domain names may be renewed a maximum of 90 calendar days before the expiry date.
- 2.3 There is a 3 calendar day grace period during which a domain name registration can be deleted or a renewal cancelled with immediate effect, and the fee refunded to the registrar.

## 3. DOMAIN NAME EXPIRY

- 3.1 The following procedure applies in the case of domain names that are not renewed on or before the expiry date:
  - a) domain name is removed from the DNS (ie. no longer works on the Internet);
  - b) domain name enters "serverUpdateProhibited" and "serverHold" status for 14 calendar days;
  - c) domain name can be renewed whilst in "serverUpdateProhibited" and "serverHold" status;
  - d) after 14 calendar days, domain name enters "pendingDelete" status and cannot be renewed;
  - e) domain name is randomly dropped within the next 7 calendar days and becomes available for registration.

# 4. DOMAIN NAME DELETION

- 4.1 The following procedure applies in the case of domain names that are deleted at the request of the registrant:
  - a) domain name is removed from the DNS (ie. no longer works on the Internet);

- b) domain name enters "pendingDelete" status for 3 calendar days;
- c) domain name can be reactivated whilst in "pendingDelete" status;
- d) after 3 calendar days, domain name is dropped immediately and becomes available for registration.
- 4.2 The following procedure applies in the case of domain names that are deleted on the instruction of the registrar under the Complaints (Registrant Eligibility) Policy (2004-01), or on the instruction of auDA under the Domain Name Eligibility and Allocation Rules for Open 2LDs (2005-01):
  - a) domain name is removed from the DNS (ie. no longer works on the Internet);
  - b) domain name enters "serverUpdateProhibited" and "serverHold" status for 14 calendar days;
  - c) domain name can be reactivated whilst in "serverUpdateProhibited" and "serverHold" status;
  - d) after 14 calendar days, domain name enters "pendingDelete" status and cannot be reactivated;
  - e) domain name is randomly dropped within the next 7 calendar days and becomes available for registration.
